### SPECIAL ISSUE: **Political forests of Europe** – Call for Papers

Forests Monitor announces a Special Issue (SI) exploring advancements in forest policy science, inspired by the International Forest Policy Meeting (IFPM). This biennial event focuses on forest-related issues through a social science lens, uniting scholars globally. The SI aligns with IFPM5, held in Helsinki in April 2024, and emphasizes the conference's key topics and themes.

#### Special Considerations

- The primary goal of this Special Issue is to deepen the understanding of the multifaceted nature of political forests, and political forestry, examining different issues of forest governance, and generating insights on the future of forests in Europe, including but not limited to:
- Forest governance in the EU as a whole and in nation states.
- Knowledge, data, and evidence in a political forest.
- (Forest) land use, forest owners, and land conflicts.
- Inequality, intersectionality & gender in forest policy and practice.

#### Submission Guidelines

Authors are invited to submit original research articles, reviews, and case studies that align with the themes outlined below. Submissions should adhere to the Journal's guidelines and will undergo a rigorous double-blind peer-review process. The **deadline** for manuscript submissions is **March 15, 2025**. ### CLOSE TO NATURE AND CLOSE TO PEOPLE FORESTRY: BUILDING RESEARCH AND EDUCATION CAPACITY FOR UKRAINE WITH A TRAINING SCHOOL

The BFH-HAFL School of Agriculture, Forestry, and Food Sciences (HAFL) at Bern University of Applied Sciences (BFH), an IUFRO member, is fostering forestry collaboration with Ukraine. Efforts include a Training School titled "Close to Nature and Close to People Forestry," focused on enhancing research and education. HAFL also launched the Close-to-Nature Forestry Network in Ukraine to share knowledge and innovations in digitalization and forest landscape governance. Additionally, pilot demonstration sites (martelosopes) have been established as training facilities to practice close-to-nature forestry, accessible via [martelage.sylvotheque.ch](http://martelage.sylvotheque.ch).

These actions include strengthening forest science to support evidence-based post-war forest recovery strategies, innovation in forestry research and education and building international partnerships and enhancing collaboration.

**Within our ongoing project RESONATE (<https://resonateforest.org/>) Blasius Schmid and Alice Ludvig from the EFI-FRPN team are involved in carrying out a policy workshop in Brussels**

Date: 10 February 2025, 12:00 – 17:00 Venue: Representation of the State of North Rhine-Westphalia to the European Union | Rue Montoyer 47, 1000 Brussels, Belgium Hosted by the RESONATE consortium.

The RESONATE project seeks to strengthen forest ecosystem and value chain resilience by offering tailored solutions and best practices for stakeholders. The major RESONATE's policy findings that we will be discussing address three main topics: (1) Resilience and climate change adaptation, (2) Disturbance risk management and (3) Value chain resilience.

The policy workshop and roadshows are designed for policy actors, decision-makers and experts in forest ecosystems, forest management and forest-based industries across Europe. A focus is on European Commission staff from relevant DGs, European advocacy groups and national representatives. The aim is to introduce this key target group to the main results and provide a platform to jointly reflect on their relevance for EU forest policy processes. ## CROSSEU PROJECT FEATURED IN FUTURES4EUROPE PLATFORM



"The CROSSEU project (<https://crosseu.eu/>)- in which Alice Ludvig at BOKU-INFER is leading the the work package on analysis for policy and governance implications within adaptation and mitigation policies has been featured this week on futures4europe. This is a foresight online platform for the Research and Innovation (R&I) foresight community in Europe. You can explore more about the platform and its features here. Futures4europe serves as a dynamic hub that accommodates the interests of a diverse group of stakeholders, including foresight experts, beneficiaries, domain specialists, and an active audience. The platform plays a key role in connecting various actors in the foresight field, offering a space to map organizations and experts, share foresight results, and showcase the capabilities of ongoing projects."

## Erasmus+ project ForestPost - cooperation with employers to ensure green reconstruction of Ukraine

For the first time, NTUU has won the ERASMUS+ Capacity Building in Higher Education (CBHE) competition as a coordinator and will lead the three-year project "Modernization of Master's Programs to Support the Post-War Green Reconstruction of Ukraine" (ForestPost). Among 765 applications under Erasmus+ CBHE-2024 Strand 2, only 79 (10.3%) were selected for funding.

The project consortium includes the National Forestry University of Ukraine (coordinator), National University of Life and Environmental Sciences of Ukraine, State Biotechnology University, University of Valladolid (Spain), University of Sustainable Development Eberswalde (Germany), and Transilvania University of Brasov (Romania). ForestPost aims to foster collaboration between higher education institutions and forestry organizations to support Ukraine's green post-war reconstruction through new academic disciplines rooted in a dual education approach, addressing critical challenges and equipping students with essential green skills.
